

1. The ownership of the Shop No. (shop no with address of shop) and its legal possession will remain with Pt. B. D. Sharma, University of Health Sciences Rohtak, Licencee will have right to use the shop as licencee during the licence period for the required business only.
2. That the licencee will have to deposit one month advance Licence fee, Service Tax as per rates quoted/prescribed by Central Excise Govt. of India from time to time in the shape of demand draft, banker cheque, pay order in the name of controller of finance, UHS, Rohtak and will also deposit Security Money in the shape of Fixed Deposit of Rupees equals to Licence Fee of One Year of the said shop issued from any Nationalized Bank/ Public Sector Bank duly pledged in the name of Registrar Pt. B. D. Sharma University of Health Sciences, Rohtak. The licencee will be required to submit an undertaking incorporating terms and conditions of licence on a non judicial stamp paper of Rs. 100/- duly attested by Executive Magistrate, Rohtak within two weeks of the provisionally acceptance of tender. Thereafter, shop will be licenced out. If licencee do not complete these required formalities within stipulated period (two weeks) then the licence awarded/accepted provisionally shall be cancelled and the earnest money and other amounts deposited by him shall be forfeited.

10. The licence period will be for one year unless terminated earlier by the Competent Authority for violation of the terms and conditions of the undertaking or any other malpractice & extendable for another two years on yearly basis subject to satisfactory report with the condition that Licence Fee of the said shop will be increased by 10% of the Licence Fee per year.
11. No space outside the Shop/Canteen etc. for any purpose is allowed to be used. Veranda of the Shop/Canteen etc. will not be utilized for any purpose by the licensee. 18. The Shop/Canteen etc. can be inspected at any time by the Competent Authority or any other officer/official deputed/Authorized by him on his behalf.
19. The licensee shall be responsible to maintain all reasonable standard of cleanliness and hygiene in the Shop/Canteen etc. and the surrounding area and disposal of garbage as per pollution control board / healthy environmental norms, in default a fine upto Rs. 10000/- at First instance and Rs. 20000/- & 30000/- on subsequent defaults can be imposed on the licensee by Competent Authority of this institution. In violation of terms and conditions more than 5 times his licence shall be cancelled.
20. The approved articles/ items sold/ stored for sale in the Shop/Canteen etc. shall be of good quality. If anything of sub-standard quality is found, Competent Authority or any other officer authorized by him on his behalf may seize the whole stock or part thereof and order the destruction there of. 31. The sample of the articles can be collected at any time by the Competent Authority or his representative and if found substandard, appropriate punishment including cancellation of licence can be imposed.
32. If a Shop/Canteen etc. remains closed for more than 7 days, it will be presumed to have been closed down and in that situation the licence shall be cancelled without issuing any notice and the security and other amount deposited by him shall be forfeited.
33. The licensee shall maintain the said premises in satisfactory and good condition and shall not allow damage to be caused to such structure given out to him. In case of any loss or damage, the same shall be recovered from him.
34. If there is a dispute, the matter will be referred to an Arbitrator who would be the Vice-Chancellor, UHS, Rohtak or will be appointed by him. In case of legal dispute, the jurisdiction shall be at Rohtak in all respect.

If first, second & third bidder do not fulfill the required formalities then earnest money of first, second & third bidder shall be forfeited and then fresh tender will be re-advertised.
51. The pharmacist/ firm must have minimum turnover of 50,00,000/- (Rs. Fifty Lacs) per year of wholesale/retail/Chemist shop during last three years. In support (proof) of annual turnover the following documents should be enclosed with the tender form:
 - a. Copy of audited Balance Sheet (duly attested) of last three years.
 - b. Attested copies of VAT/GST Returns submitted in last three years.
52. Self Attested photocopy of the valid licence for sale of drugs/ medicines issued by appropriate Drug Controller under the Drug and Cosmetic Act 1940 for carrying out business of selling of medicine etc.

 - Dates of manufacturing
 - Date of expiry
 - Discount
 - Net amount.
58. a) The unused items will be taken back within three days of the discharge/final treatment of the patient, subject to the condition that the date of expiry, MRP and batch No. is printed and clearly visible on the medicines/ surgical items being returned. Any applicable tax already charged and which cannot be refunded will be borne by the patient.






- b) The licensee shall display the scheduled time for exchange/ return of the medicines and depute an extra salesman for this purpose.
