It is for the information of all the eligible candidates desirous of seeking admission to MD/MS/MDS courses in all Government/ Government Aided/ Private Unaided Medical/Dental Institutes including those under Private Universities - SGT University, Budhera, Gurugram, PDM University, Bahadurgarh, Al-Falah University Village Dhoj, Faridabad and Post MBBS DNB/Post MBBS Diploma/Post Diploma DNB courses in Civil Hospitals in the State of Haryana for the academic session 2023-24, the tentative schedule of STRAY ROUND counseling for left over seats after Round-3 is as under :-

Note:-

- The candidates who have already registered themselves for the Round-1, Round-2 & Round-3 and wish to participate in the Stray Round, shall not be required to register again.
- The candidates who have already "joined" on any seat allotted to them through All India Counseling/Any State Counseling shall not be eligible to participate in the Stray Round/further round of counseling even after resignation.
- No Up-gradation of any seat shall be allowed.
- All candidates (already registered (irrespective of their admission status) and freshly registered candidates) who wish to participate in the Stray Round of counseling and want to opt for State Quota Seats in only Government/Government Aided/ Private Unaided Medical/Dental Colleges/hospitals shall be required to deposit security fee online an amount of Rs. 25,000/- (Rs. 12,500/- for SC/SCD/BCA/BCB/EWS/PWBD of Haryana State) and if the candidate wishes to also opt for State Quota Seats/Management Quota Seats in Private Medical/Dental Colleges including Private Universities the he/she shall have to deposit online an amount of Rs. 2.00 Lakh. This facility shall be available in the login ID of the candidates on admission webportal.
- In case of failure of any registered candidate to deposit the requisite security amount, they will NOT be considered eligible to participate in the Stray Round of counseling.
- If the candidates are allotted any seat as per their preference, but they do not join on the allotted seat, the security amount shall be forfeited.
- The security amount of the candidates who are not allotted any seat shall be returned after the completion of the counseling process.
- In case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled during document verification or fails to produce the required documents at the time of document verification, the security amount fee shall be forfeited.
- The candidates who are found eligible after successful document verification on 19.10.2023 during process of physical document verification will be treated as "joined" in allotted institutions on the spot. Any candidate who "Join" the allotted seat in Stray Round, shall not be eligible to participate for further round of counseling (if any).
- The choices filled by the candidates for the Round-1/ Round-2/ Round-3 of counseling shall be treated as null and void and the candidates will have to fill fresh choices for Stray round.
- The above instructions should be read in accordance with NEET PG information bulletin 2023 and Govt. of Haryana notifications dated 02.08.2023 and 09.08.2023 and public notices issued by DMER/MCC/Admission Committee time to time.
