

1. The **physical presence** of the candidates participating in the verification of documents is **mandatory**.

    - c. Experience Certificate, if any, issued by the concerned Authority.
  - v. One ID Proof: Aadhar Card/Driving License/Passport/Voter ID.

- vii. Kindly bring duly filled Undertaking (if required) and Scrutiny Proforma uploaded on University website alongwith Notification at **Annexure-A&B**, respectively.

5. Haryana Domicile Certificate/Reservation/Category Certificate in original in case of BCA/BCB/SC/ESM/DESM/DFE etc. as applicable issued by competent authority.
6. Creamy/ Non Creamy certificate in original for BC-A/ BC-B category candidates as per Govt. of Haryana notification dated 17.11.2021.
7. Income and Asset certificate in original for EWS category candidates issued by competent authority.

DESM candidates of Haryana claiming benefit must have valid eligibility certificate on last date of submission of online application form and will have to produce the valid Eligibility Certificate from the concerned Zila Sainik Board at the time of scrutiny. Mere dependent certificate will not be entertained. ESM candidates should also produce attested photo copy of Identity Card issued by concerned Zila Sainik Board and Discharge Book at the time of scrutiny.
